# POLICIES & DISCLAIMERS

- 1. A valid, current photo ID is required for student pickup.
- 2. Action Youth America (AYA) accepts Student Registrations all year long.
- 3. Space and funding for this program is limited. Students are enrolled on a first come, first served basis. Completion of a registration form may not guarantee a spot in the program. Students who cannot be placed at the time of registration will be put on a waiting list and will be placed in the program on a first come, first served basis as spots become available.
- 4. Once registered, registration is in effect continuously until the end of the school year.
- 5. Attendance: Daily attendance in the Action Youth America Program is extremely important to keep your child enrolled. Students may only attend Action Youth America (AYA) After-School Programs on the days they attend regular school. They are expected to stay for the entire program and/or until 6pm EVERY day. Students with three unexcused absences or early pick-ups may be dismissed from the program. Excused absences include illness, occasional appointments (doctor, dentist, etc.), and court mandated appointments. For early pick-ups, please complete an Early Release Form.
- 6. **Homework:** Please note: *This is a Homework Assistance program, not a Homework Completion program, although we will make every effort for students to complete their homework.* Students will have an opportunity to work on assigned homework in accordance with District grade level guidelines on appropriate homework time increments during Action Youth America (AYA) After-School Programs. However, it is still the parent's responsibility to follow-up to ensure homework is fully completed.
- 7. **Discipline:** Participation in the Action Youth America (AYA) Program is a privilege. Students must follow the standard rules of both the school and program. Disruptive or disrespectful behavior towards other students and/or Action Youth America (AYA) Program staff is cause for dismissal. Physical fighting, drugs, weapons and vandalism and any violations under Ed Code 48900 and 48915 will not be tolerated.
- 8. **Student Pick-Up:** Program hours are from School Dismissal until 6:00PM Monday through Friday on school days only. Regular student pick-ups are between 5:45PM and 6:00PM. Students must be signed out and picked up by a parent, guardian, or pre-designated individual with a valid photo ID promptly by the conclusion of the program day. Failure to do so will result in a Late Pick-up report and the student may be dismissed from the program.
- 9. Please note that we cannot provide childcare beyond 6PM. For the safety of your child, please make sure you make arrangements to pick up your child on time. Students must be picked up by an authorized person by no later than 6:00PM. A child not picked up by 6PM may be considered "abandoned". Staff is required to contact the Police Department and/or Child Protective Services. Please note, your child will only be released to authorized persons. Please make sure the person picking up your child is registered with Action Youth America (AYA) as an "Authorized Pick-up Person" and is required to show a valid photo ID.
- 10. **Parental Support**: Parents/guardians are encouraged to participate in after-school events, activities, and other projects to help support students as they participate in different activities and explore learning and community outreach.
- 11. Two week's advance notice in writing must be received to withdraw from the program at any time.
- 12. As the undersigned parent/guardian you are responsible for the accuracy of any and all information provided on the registration form.
- 13. Action Youth America (AYA) staff agree to maintain standards established by the California Department of Education After School Education and Safety (ASES) program and the federal No Child Left Behind legislation.
- 14. Only students who are registered are allowed to participate in the program.
